1. Essentially, the Appellants are aggrieved by the order dated 18.04.2023 passed by the Ld. Deputy Commissioner under Section 185 of the Delhi Land Reforms Act, 1954 whereby the rights of the Appellants are hit. It was pointed out that the said village Narela has been urbanized on 20.11.2019 and Gazette Notification has also been seen to this effect. In terms of the recent judgement dated 14.03.2023 passed by Hon'ble Supreme Court of India in case titled ***Mohinder Singh (Dead) through LRs and Another Vs. Narain Singh and Others***, proceedings under Delhi Land Reforms Act, 1954 cannot be continued post urbanization and all such proceedings are non-est in the eyes of law. Therefore, before any action is taken against the Appellants, it is imperative to grant a stay in this matter qua the rights of the Appellants as referred above till further hearing. Stay is so granted.
