5. Be that as it may, the said village is covered under L.D.R.A. Notification dated 18.06.2013 and two recent rulings dated 10.04.2023 & 25.05.2023 of the Hon'ble High Court in WP(C) No.3502/2022 titled ***Rajeev Shah (Deceased) through LR Gayatri Shah Vs. Government of NCT of Delhi & Ors.*** and in WP(C) No.7159/2023 titled ***Shweta Agarwal & Anr. Vs. Govt of NCT of Delhi & Anr.*** respectively have held that the villages which are notified as L.D.R.A. villages are no longer covered under the Delhi Land Reforms Act, 1954.
6. Therefore, it is imperative that the impugned orders are stayed from further operation. The impugned orders are, therefore, stayed.
