Government of NCT of Delhi & Ors.*** and in WP(C) No.7159/2023 titled ***Shweta Agarwal & Anr. Vs. Govt of NCT of Delhi & Anr.*** respectively have held that the villages which are notified as L.D.R.A. villages are no longer covered under the Delhi Land Reforms Act, 1954.
