1. Heard the Ld. Counsel for Petitioners.
2. The matter in short is that the Petitioner is aggrieved by the impugned orders dated 26.03.2024 passed by the Deputy Commissioner/Collector (Central District) under the Delhi Land Reforms Act, 1954. Vide these orders, Deputy Commissioner/Collector has upheld the impugned orders dated 24.09.2018 passed by the SDM/RA (Civil Lines).
3. The case of the petitioner is that the said village Kamalpur Majra, Burari stood urbanized on 16.05.2017 and in terms of the judgment dated 14.03.2023 passed by the Hon'ble Supreme Court of India in case titled **"Mohinder Singh (Dead) through LRs and Another Vs Narain Singh and Others"** and the judgment dated 20.12.2023 passed by the Hon'ble High Court of Delhi in case titled **"Jitender Vs. Govt. of NCT of Delhi & Ors."**, the revenue laws do not apply to such holdings that have since been urbanized. The petitioner has also submitted that this ground was taken before the lower court but the same has not been addressed in the impugned orders.
4. Be that as it may, no consequential action can be taken in terms of the impugned orders by any party at least till the conclusion of the proceedings before this court.
5. Interim Orders to continue till the next date of hearing and Status-Quo on the ground shall be maintained by all the parties till the proceedings are concluded in this Court.
6. Issue Dasti notices, on filing of PF & RC.
7. As requested, orders be given Dasti to the Ld. Counsel of the Petitioners.
