## **Case Nos. 344 of 2024**

1. The matter was mentioned by the Ld.Counsel.
2. Petitioner is aggrieved by the orders of this court dated 19.09.2024 wherein the Respondents have been mentioned as Gram Sabha Bijwasan instead of Gram Sabha Bharthal.
3. Petitioner's case is that it was inadvertent mistake by the Petitioner to refer Gram Sabha Bharthal mistakenly as Gram Sabha Bijwasan in the memo of parties and the Petitioner prays to have said memo of parties of Respondents be corrected.
4. It is seen that the impugned order passed by this court as well as notice issued in the original revision petition no.134/2024 were addressed rightly to the Gram Sabha Bharthal and only the error has crept in the memo of parties which the Ld.Counsel for the Petitioner accepts was inadvertent mistake on the part of the office of the Ld.Counsel.
5. On the face of it, the same deserves to be corrected as being mere technicality. However, in the interest of justice, issue notice to the said Gram Sabha Bharthal before proceeding further.
