1. The matter was mentioned and heard.
2. The Appellant hospital (i.e. Irene Hospital) is aggrieved by the order dated 18.03.2025 vide which the license of the Appellant hospital was cancelled. The Appellant's specific grievance is that the Appellant had complied with all the deficiencies as communicated to the Appellant vide Show Cause Notice dated 31.01.2025 vide his reply dated 18.02.2025. The Appellant is particularly aggrieved that the cancellation order does not mention any specific reason which was part of the Show Cause Notice as to be the ground for cancellation. To that extent, the cancellation order is seen and the cancellation order does not indicate any such reason.
3. Clearly, the cancellation order is a non-speaking order and the prayer of the Appellant for interim protection is, therefore, granted. No coercive action be taken in terms of the cancellation order dated 18.03.2025 qua the Appellant hospital till the next date of hearing.
4. The Ld.Counsel for Appellant also submitted that the said hospital is functional since 2012 or so. This is to be confirmed in writing by the Appellant on the next date of hearing.
5. Issue notice dasti to the Respondent, DGHS.
6. As requested by the Ld.Counsel for Appellant, a copy of this order be given dasti.
