The Petitioner's case is that in the year 1973 vide orders dated 28.05.1973, the Revenue Assistant had passed orders in case No.97/1972 that the Petitioner here has been in continuous adverse possession of the Gram Sabha land for more than three years. The Petitioner's case is that these orders are completely at variance with the findings arrived at by the SDM/RA on 13.07.2022 that the Petitioner is not having any right to be in possession of the impugned land. The Petitioner's ground is that the orders dated 13.07.2022 are at variance with the decision arrived by the RA in 1973. The Petitioner also relies upon the series of khasra girdawari documents which shows his possession of the impugned land upto the year 2020, at least for over two decades.
3. The R-1, Gram Sabha to file its reply covering the above arguments before the next date of hearing.
4. The DDA also be impleaded as a party since the Gram Sabha has stated that the impugned land is now in their possession post urbanization. Accordingly, the Petitioner to file amended memo of parties and have the notices served.
5. In the meantime considering the chequered nature of the case and the documents available on record especially the orders of the RA dated 28.05.1973, interim protection is allowed to the Petitioner and no

third party interest shall be created on the impugned land during the pendency of the proceedings here.
