1. Heard the parties.
2. The Petitioner Bank filed the present revision petition against the impugned order dated 13.01.2025 passed by the Registrar Cooperative Societies wherein the Petitioner Cooperative Bank was directed to provide the details of accounts settled through the one time settlement scheme and the entire service record of Shri Atul Bhardwaj to the office of the RCS.
3. During the hearings in the matter on 25.04.2025, the Petitioner Bank brought to the notice of the court the communication dated 19.03.2025 issued by the Assistant Registrar wherein it was directed to comply with the directions of the RCS communicated vide order dated 13.01.2025 issued under Section 138 of the DCS Act. The Bank also submitted the proceedings dated 27.03.2025 of the Legislative Assembly of National Capital Territory of Delhi wherein it is mentioned that the House has decided that *"no further action be taken on the pending matters referred to the Committee of Privileges, Committee on Petitions and Questions and Reference Committee during the VI and VII Assembly and the same may be treated as disposed."*
4. Today, the Ld. Counsel for Petitioner Bank has argued that since the Legislative Assembly itself has disposed of the pending matters including the present one

whereby the information was sought through RCS from the Petitioner Bank, therefore, no purpose would be served by continuing with the present proceedings and the same may be disposed of being infructuous.

5. Upon query by the court, the Ld. Counsel for Respondent, RCS did not press for the implementation of its order dated 13.01.2025 as well as 19.03.2025 and requested for passing of orders.
6. As can be seen from the above, the impugned orders have been passed by the RCS in pursuant to unstarred Question Nos.179 & 180 raised in the previous Delhi Legislative Assembly which were further acted upon by the Privileges Committee of the Legislative Assembly of National Capital Territory of Delhi. Since the Legislative Assembly itself vide its Bulletin/Brief Summary of Proceedings dated 27.03.2025 (Item No.09) has decided that no further action shall be taken on the pending matters referred to the Committee of Privileges, etc. and the same shall be treated as disposed, hence, the impugned orders dated 13.01.2025 and 19.03.2025 are not to be acted upon further. Accordingly, in terms of the decision taken by the Hon'ble Delhi Assembly vide its communication dated 27.03.2025, the present revision petition is disposed of as being infructuous.

1. The matter was mentioned and heard.
2. The Petitioner's case is that the Mediation Court on 06.03.2020 had drawn up a schedule of repayment starting from 19.03.2020 to 19.02.2021 totalling amount of Rs.3,20,000/- and the Petitioner has already paid Rs.3,10,000/- so far. The Petitioner's case is in particular is that the repayment schedule unfortunately coincided with Covid-19 period which started from March, 2020 to May, 2022 and therefore the Petitioner was not in a position to settle the amount. The Petitioner further states that only Rs.20,000/- payment is pending as per settlement drawn and the Petitioner has also given in writing to Respondent, Society to give details of pending amount and the Petitioner has expressed his desire to settle the dues in terms of law at the earliest. The Petitioner has, therefore, submitted to the court to protect the Petitioner from any coercive action including arrest etc. which the executing court has initiated.
3. Seeing the facts of the case as above, it is imperative that the Petitioner is given an opportunity to settle the dues in terms of all the pending payments after the accounts are reconciled. Therefore, no coercive action qua the Petitioner is to be taken till the executing court re-visit the pending payment with the Petitioner and the Respondent Society gives the Petitioner an opportunity to clear the dues especially

since the repayment schedules coincided with Covid-19. The efforts made in this regard by the executing court shall be taken up in this court for further hearing when the Respondent, RCS shall file affidavit on the efforts made.
