3. From a perusal of the documents placed on file, it is seen that the present impugned order dated 09.05.2025 has been issued by the Ld.Excise Commissioner, in pursuance of the order dated 13.02.2025 passed by this court, thereby reiterating the earlier stand of the department to reject the L-1 license application of the present Appellant vide order dated 13.04.2023 passed by the Deputy Commissioner (Excise)/ Licensing Authority which was further upheld by the Excise Commissioner, Delhi vide order dated 23.07.2024.
4. From the records, it is seen that the present impugned order dated 09.05.2025 has been passed by the Excise Commissioner, Delhi ostensibly taking into account all the contentions of the Appellant in a comprehensive manner as well as the directions passed by this court vide its order dated 13.02.2025. However, to stay the operation of the impugned order or any other directions passed ex-parte, would cause prejudice to the Respondent, Excise Department. In the interest of justice, it is, therefore, necessitated that the stand of the Excise Department is heard before any directions are further issued in the present matter. Consequently, the application on behalf of the Appellant for interim relief is, therefore, not allowed.
