1. The matter was heard. The short point of the Petitioner is that vide impugned letter dated 18.01.2023, the Special Audit was ordered by Assistant Registrar (Audit)/R-2 regarding the payment of the fee and circular dated 03.03.2010 was cited for settlement of the fee. However, the said circular does not deal with the fee for Special Audit. The Special Audit is covered by Rule 81(1) of the Delhi Cooperative Societies Rules, 2007 wherein the fixation of quantum of Audit fee is as per the approval of the Govt.
2. The issue raised by the Petitioner is that initially the said circular quoted above was referred to in the order of the Respondent, RCS and only later on higher Audit fee has been directed to be paid by the Petitioner society without clarifying as to whether the higher Audit fee was actually got approved by the Govt. in terms of the Rule 81(1) of the Delhi Cooperative Societies Rules, 2007.



3. The reply of the Respondent, RCS has not specifically covered this aspect. The Ld.Counsel for RCS to clarify the same and is directed to do so in writing before the next date of hearing based on the documents available on record so that the matter can be taken up for orders.

1. The matter was mentioned and heard.
2. The Petitioner bank is aggrieved by the communication dated 19.03.2025 of the R-1, RCS as received by the Petitioner bank, as per the Petitioner on 19.04.2025. Vide this communication, the R-1, RCS has directed the Petitioner bank to comply with the original orders of the RCS dated 13.01.2025. Essentially, the said order dated 13.01.2025 is a follow up vide series of action originating from initial information sought from the Petitioner bank on 22.04.2022. This information was pursuant to an unstarred Q.No.179 & 180 raised in the Delhi Legislative Assembly and as acted upon further by the Privileges Committee of the Delhi Legislative Assembly. As per the said communication, some information was to be provided by the Petitioner bank to the Delhi Legislative Assembly through the office of the R-1, RCS.
3. The Petitioner brought to the notice of this court the decision of the Delhi Legislative Assembly on 27.03.2025 where the Delhi Legislative Assembly has decided that no further action be taken on the pending matters referred to the Committee of Privileges, Committee of Pensions and Question Reference Committee during the 6<sup>th</sup> & 7<sup>th</sup> Assembly and the same may be treated as disposed.
4. Therefore, the Petitioner is specifically aggrieved that any follow up action by the R-1, RCS vide their recent communication dated 09.03.2025 as received on 19.04.2025 is infructuous since 27.03.2025. The same stood nullified by the originator of the

information i.e. Delhi Legislative Assembly Committee of Privileges.

5. Therefore, the Petitioner prays that the Petitioner bank be protected from any adverse action as a consequence of this communication dated 19.03.2025.
6. In view of the documents filed by the Petitioner and averments of the Petitioner, it is directed that no adverse action be taken qua the Petitioner bank by the R-1, RCS during the pendency of this case in terms of the impugned communication dated 19.03.2025.
7. To come up on 08.05.2025 for final arguments as already scheduled.
